The conference will end on **September 21 at about 13:45**. Afterwards, WU is happy to invite you the **Inaugural Lecture of Dr. Jeffrey Owens**, former Director of the OECD Centre for Tax Policy and Administration. The fee for the conference is EUR 1,000.--. A waiver of the conference fee may be granted to professors and other researchers (full-time academics) who are employed at a university or another academic institution (wherever located) and who have been engaged in research activities related to the conference topic. Civil servants can also be granted a waiver of the conference fee, upon request. The conference fee must be paid not later than **August 15, 2012**, and will not be refunded in the case of cancellation one week prior to the conference. (The conference fee allows you to participate in all the four conference sessions and includes the coffee breaks, dinner on Thursday night, the delegates' pack and internet access in the conference room during the event. Travel and hotel accommodation are not included).
